**APPLICATION FOR PURCHASE, TRANSFER, GIFT, DIVISE OR INHERITANCE APPROVAL**

1. This application, an application for approval, and authorization forms must be completed in detail by each proposed adult occupant.
2. If any questions is not answered, or left blank, this application may be returned, not processed and not approved.
3. Please attach a copy of the signed purchase agreement to this application.
4. Please attach a non-refundable \$100.00 processing fee to this application, made payable to the Sorrento at The Colony Condominium Association, Inc. for each applicant. Acceptance of the processing fee does not in any way constitute approval of this transaction.
5. An Owner must provide the Board of Directors with written notice of intention to sell the Unit at least fifteen (15) days prior to the first occupancy, together with the name of the proposed Lessee, a fully executed copy of the proposed purchase agreement, a properly completed application to purchase form, processing fee and such other information as the Board of Directors may reasonably require. The application to purchase form authorizes the Board of Directors to obtain a background check of the proposed purchasers.
6. After the required application and all attendant information requested, including background check report, have been received by the Board of Directors, the Board of Directors shall have fifteen (15) days in which to approve or disapprove the proposed purchase.
7. All applicants must make themselves available for a personal interview if requested by the Board of Directors prior to final approval. Occupancy prior to Board of Directors approval is prohibited.
8. Pet Policy: One dog no more than fifteen (15) inches tall at the shoulder at maturity, or two cats , and no more than two birds, tropical fish, and other customary non-exotic (snakes prohibited), quiet inoffensive household pets not being kept or raised for commercial purposed shall be permitted. I also understand that guests or visitors may not have any pets. See SORRENTO Rules & Regulations for further information.
9. Use of this unit is for single family residence only.

Hours for moving are from 8:00 AM to 4:00 PM, Monday through Friday. No furniture moving is permitted on Saturdays, Sundays or holidays, unless approved by the Manager.
