3. Please attach a copy of the lease to this application.
4. Please attach a non-refundable \$100.00 processing fee to this application, made payable to the **Sorrento at The Colony Condominium Association, Inc.** for each applicant. Acceptance of the processing fee does not in any way constitute approval of this transaction.
5. The Owner must provide the Board of Directors with written notice of intention to lease the Unit at least fifteen (15) days prior to the first occupancy, together with the name of the proposed Lessee, a fully executed copy of the proposed lease, a properly completed application to lease form, processing fee and such other information as the Board of Directors may reasonably require. The application to lease form authorizes the Board of Directors to obtain a background check of the proposed lessee(s).
6. After the required application and all attendant information requested, including background check report, have been received by the Board of Directors, the Board of Directors shall have thirty (30) days in which to approve or disapprove the proposed lease.
7. All applicants must make themselves available for a personal interview if requested by the Board of Directors prior to final approval. Occupancy prior to Board of Directors approval is prohibited.
8. No lease shall be for less than thirty (30) days, and no more than three (3) leases in a twelve month period.
9. Use of this unit is for single family residence only.
10. Assigned Parking Space(s) is _____.
11. Commercial vehicles, trucks, boats, trailers, motor homes and campers are prohibited.
12. The Owner must provide the lessee(s) with a copy of the Association Rules and Regulations.
